**Fiscal Officer's Report:** SUV final payment has been made. Safe deposit box was closed at Farmers State per the State Auditors. Coblentz Insurance renewal is up on June 9<sup>th</sup>; updated information will be sent to Coblentz by May 25<sup>th</sup>.
